Bringing territoriality to Interreg

Under the slogan '[Bringing territoriality into Interreg](#)' Interact works together with the Interreg community and national, regional and local territorial actors on strengthening the territorial dimension of Interreg cooperation (programmes and projects). The work started back in 2020 with events on the notion of territoriality and functional areas and focused in 2021 on the linkages and interaction between Interreg and the Territorial Agenda 2030. It is now high time to move from awareness raising and the conceptual discussion to the day-to-day implementation level ...

Outline

... to the day-to-day implementation level showcasing that the notion of territoriality in Interreg is not just a nice-to-have concept. Making things work across borders is the unique selling point of European Territorial Cooperation. Hence, territoriality in functional areas across borders and countries is not just a concept, but something tangible and already happening on the ground.


A functional area is a bounded space or geographical area formed by a set of linkages, interactions and interdependencies, which are defined by a certain function (e.g., education, health, employment, leisure activities).

But what could that mean in practice? And is the concept of functional areas relevant for any border region? Or more intended for borders where their geography is not as conditioning as in other areas, such as mountain areas, rural areas with risk of depopulation, and hardly permeable borders?

It is not administrative boundaries defining a functional area. Interactions and interdependencies based on functions define such areas! In the context of Interreg (potential) functional areas like cross-border conurbations or agglomeration areas spreading their commuter catchment areas across borders rank among the territorial hot spots. Territorial hot spots where the functions of living and working across borders pose new opportunities and challenges for cooperation across local and national borders. People are interested to have access to functioning transport networks, good jobs, efficient public amenities, affordable housing and options to enjoy leisure time. They can't see borders - be it national or administrative borders - they want to live in a functioning conurbation or border region.

Objectives

With this event organised by Interact within the framework of the [French Presidency of the Council of the European Union](#) we want to present a couple of examples of European cross-border functional areas and to highlight practical approaches to their governance. Functional areas which are practising territoriality in their everyday activities and hence are home turfs and best practice cases for territoriality. Hereby, we want to show the added value of strengthening the territorial dimension in Interreg, in cooperation across borders.
